Dear Sir,

- 1. The Board of Directors of the Company vide its circular resolution dated February 12, 2019 has appointed me as a Scrutinizer for conducting the postal ballot voting process.
- 2. I submit my report as under:
- 2.1 The Company has completed on February 23, 2019 the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared in the Register of Members/list of beneficiaries as on February 12, 2019. The Company has also made arrangement for e-voting with CDSL.
- 2.2 Particulars of all the postal ballot and e-voting forms received from the Members have been entered in a register separately maintained for the purpose.
- 2.3 The postal ballot forms were kept under safe custody of Link Intime India Private Limited, in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 2.4 The ballot boxes were opened on March 26, 2019 and March 27, 2019 in my presence.
- 2.5 The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company/ list of beneficiaries as on February 12, 2019.
- 2.6 All postal ballot forms received up to 5.00 p.m. on March 27, 2019, the last date and time fixed by the Company for receipt of the Postal Ballot Forms were considered for my scrutiny.
